## Right of Use Form

I certify that I am a representative of the band who's music I have provided to Quickstar Productions LLC and that I am acting on behalf of and with the consent of my band when agreeing to take part in this project. I certify that I have permission to use and distribute the music that I have provided. I agree that Quickstar Productions LLC has the right to include my song on the Compilation CD that they are producing which will be available for sale in both physical and digital formats. I realize that I retain full ownership and copyrights to my included work and that this agreement acts only to allow the inclusion of my work in a limited capacity. The right of Quickstar Productions LLC, to produce the compilation CD that my work will appear, including my work on it, shall not be terminable.

I realize that I will be paid 50% of the profits that my song generates from digital sales after my sales have reached \$10. I realize that Quickstar Productions LLC will be collecting the digital payments on my behalf. If payments are due to me they will be mailed to me within 45 days of June 1st and Dec. 31st along with proof statement to document sales. Payment shall be made out and sent to the name and address that I have provided. Checks will only be mailed for amounts greater or equal to \$10. If the \$10 amount has not been reached during the period it will roll over into the next period.

Throughout the production of the CD it may be necessary for Quickstar Productions LLC to contact me from time to time. I understand that Quickstar Productions will contact me through the email address that I have provided.

I realize that I have 10 days after notification of shipment of CDs to notify Quickstar Productions of any shipping damages or problems.
